<p>At the beginning the year, teachers access historical data in order to differentiate targets example: previous year’s assessment data, in-class formative and summative baseline assessments, attendance trends, considerations for ENL, SWD, economically disadvantaged, etc.). HEDI points are distributed based on students meeting the expected target as a percentage. Teachers with percentages from 90-100 are HE (18-20 points), 75-89 are E (15-17), 60-74 D (13-14) and 0-59 are (0-12) per the regulations.</p>
