At its October 2017 meeting, the Board of Regents adopted the Professional Standards for Educational Leaders ([PSELs - NYS Version](#)) to replace the Interstate School Leaders Licensure Consortium standards (ISLLC Standards) and further require that Educator Evaluation plans approved under Education Law §3012-d use a principal practice rubric aligned to the PSELs - NYS Version. 


