Teacher Improvement Plan – T.I.P.

- 1. A T.I.P. shall be initiated whenever a teacher receives a rating of developing or ineffective in an Annual Professional Performance Review. The Superintendent's designee shall schedule a meeting during the teacher's preparation period, common planning period or at any other mutually agreed upon time. At such meeting, the Superintendent's designee will develop the T.I.P. and inform the teacher of its contents. The Superintendent's designee may choose to include other district support staff including, but not limited to curriculum specialists, subject area coordinators, department representatives, etc. The Teacher Improvement Plan form shall be completed during the T.I.P. meeting by the Superintendent's designee and signed by the teacher and administrator(s) at the end of the meeting. A teacher's union representative is welcome at this meeting.
- 2. Implementation must begin no later than October 1st of the school year following the school year for which the teacher's performance is being measured. The T.I.P. will continue until the areas in need of improvement have been resolved to the satisfaction of the Superintendent's designee.
- 3. The parties understand and agree that the sole and exclusive purpose of the T.I.P. is improvement of teaching practice.
- 4. The T.I.P. shall clearly specify: areas in need of improvement, an action plan to support improvement, the manner in which improvement will be assessed, and a timeline for assessing improvement. Other items may be added to the T.I.P. as deemed necessary by the Superintendent's designee.
- 5. The Superintendent's designee shall schedule Progress Report meetings to take place during the teacher's preparation period, common planning period or at any other mutually agreed upon time during the months of January and March. Artifacts and evidence to determine if progress has been made in the areas needing improvement will be discussed between the Superintendent's designee and the teacher. The Progress Report form shall be completed during the Progress Report meeting by Superintendent's designee and by the teacher and administrator(s). The T.I.P. can be modified by the Superintendent's designee as needed or resolved at either the January and/or March meeting based on progress noted during the year. Upon the satisfactory resolution of the T.I.P. the teacher and administrator(s) will sign the appropriate line on the T.I.P. form. A teacher's union representative is welcome at this meeting.
- 6. If at the March Progress Report meeting, it is determined by the Superintendent's designee that the area(s) in need of improvement has not been satisfactorily resolved; a June conference may be scheduled to include the Superintendent's designee and the teacher. A teacher's union representative is welcome at this meeting. The Superintendent's designee shall schedule the June Progress Report meeting to take place during the teacher's preparation period, common planning period or at any other mutually agreed upon time. Artifacts and evidence to determine if progress has been made in the areas needing improvement will be discussed between the Superintendent's designee and the teacher. The Progress Report form shall be completed during the June Progress Report meeting by the administrator and signed by the teacher and administrator(s). The purpose of the June Progress Report meeting is to determine if the area in need of improvement has been satisfactorily resolved or if the T.I.P. shall continue into the next school year. The determination made by the administrator(s) will be indicated on the form which the teacher and administrator(s) will sign. A teacher's union representative is welcome at this meeting.

ANNUAL PROFESSIONAL PERFORMANCE REVIEW

PRINCIPAL IMPROVEMENT PLAN (PIP)

The **Principal Improvement Plan (PIP)** is a structured plan designed to identify specific concerns in instruction and outlines a plan of action to address these concerns. The purpose of a PIP is to assist principals to work to their fullest potential. The PIP provides assistance and feedback to the principal and establishes a timeline for assessing its overall effectiveness.

A PIP must be initiated whenever a principal receives a rating of *developing or ineffective* in any school year. The PIP must be in place no later than September 10th of the next school year following the developing or ineffective rating. Prior to its implementation the PIP will be signed and dated by all parties. The specific area or areas in need of improvement will be drawn from the evaluation criteria contained in the agreed upon rubric. The attached forms must be used during the PIP plan and signed by all parties.

The PIP shall clearly specify: areas in need of improvement, a detailed action plan to accomplish and support that improvement, the manner in which the improvement will be assessed, and a timeline for assessing improvement. The association president will be notified when the district notifies the principal of an ineffective or developing rating.

The PIP plan developed for the building principal must offer the Principal an experienced outside mentor mutually agreed upon by the Association and District with the cost of said mentor being paid by the district. All conversations and dealings between the mentor and principal will be confidential, unless principal provides written permission to disclose.

A statement of differentiated activities designed to support improvement in the areas identified within the PIP shall be developed by the Superintendent or his/her designee after consultation with the principal. These activities may include, but are not limited to:

- Visitations and shadowing
- Workshops and seminars
- On-line courses and webinars
- Advanced degree work
- Professional texts, periodicals, and other literature
- Collegial Circles
- Guided observations
- Self-assessments
- Modeling from leader evaluator

All costs associated with any differentiated activities shall be borne by the District.

No later than November 15th the Superintendent shall meet with the Building Principal on the PIP to discuss and assess the building principal's progress to date and provide written feedback to the principal regarding his/her progress on the PIP; on or before February 15th the Superintendent shall again meet with the Building Principal on the PIP to discuss and assess the building principal's progress and provide written feedback to the principal regarding his/her progress on the PIP; on or before April 15th the Superintendent shall again meet with the Building Principal on the PIP to discuss and assess the building principal's progress and provide written feedback to the principal regarding his/her progress on the PIP. Evidence and artifacts to determine if progress has been made in the areas needing improvement will be discussed between the Superintendent and principal at each meeting. All forms and written feedback must be signed and provided to the principal upon the completion

of each meeting. No later than June 15th shall the Superintendent meet with the building principal to determine if the area in need of improvement has been satisfactorily resolved or if the PIP shall continue into the next school year. The building principal shall be afforded union representation, if they so desire, at each meeting. If at any time, the Superintendent believes that the goals have been met by the principal he/she shall sign a written acknowledgement of attainment.

In addition to the above meetings with the Superintendent, the building principal shall meet with the Assistant Superintendent in charge of Curriculum or its equivalent non-bargaining unit administrative position periodically throughout the school year in order to discuss and assess the building principal's progress on the PIP and to be provided written feedback regarding his/her progress on the PIP. All meetings shall be documented on the attached form.

If at the end of the school year the PIP goals are met or the administrator is rated "effective" the PIP will terminate.

If the principal is rated as *developing or ineffective* for any school year in which a PIP was in effect, a new plan adhering to the requirements contained herein with any additional measures in that subsequent school year will be developed by the Superintendent following the guidelines below. The evaluated principal shall have at least eight months on the Improvement Plan to show progress prior to any possible disciplinary procedure being initiated.

Any PIP plan created must consist of the following components:

- I. <u>SPECIFIC AREAS FOR IMPROVEMENT</u>: Identify specific areas in need of improvement. Develop specific, behaviorally written goals for the principal to accomplish during the period of the Plan.
- II. <u>EXPECTED OUTCOMES OF THE PIP</u>: Identify specific recommendations for what the principal is expected to do to improve in the identified areas. Delineate specific, realistic, achievable activities for the principal.
- III. <u>RESPONSIBILITIES</u>: Identify steps to be taken by Superintendent and the principal throughout the Plan. Examples: school visits by the Superintendent; supervisory conferences between the principal and Superintendent; written reports and/or evaluations, etc.
- IV. <u>RESOURCES/ACTIVITIES:</u> Identify specific resources available to assist the principal to improve performance. Examples: colleagues; courses; workshops; peer visits; materials; etc.
- V. <u>EVIDENCE OF ACHIEVEMENT</u>: Identify how progress will be measured and assessed. Specify next steps to be taken based upon whether the principal is successful, partially successful or unsuccessful in efforts to improve performance.
- VI. <u>TIMELINE</u>: Provide a specific Timeline for implementation of the various components of the PIP and for the final completion of the PIP. Identify the dates for preparation of written documentation regarding the completion of the Plan and finalize the dates as to required meetings and/or school visits, and/or workshops, etc.
