



SUBJECT: Follow-Up -- Updated Annual Fire Inspection Report Process

This is to follow-up to my previous communication related to the updated annual fire inspection report process. The existing SED fire safety system has been updated to reflect on-line technologies, and the new on-line system is now “live”.

The new on-line fire safety system is only accessible via the secure SED Application Business Portal that is used for many other SED processes. Similar to the physical signature you previously signed on the bottom of the old fire inspection report, as the superintendent of schools or district superintendent you are now responsible for certifying the accuracy of fire inspection data provided via the Portal.

A critical aspect of the new system is the annual verification and certification of details related to the buildings in your school district or BOCES. The annual verification process must be completed prior to the entry of annual fire inspection data. Although the annual fire inspection cannot be conducted more than 45-days prior to the reports due date to SED, the annual building verification process may be conducted at any time throughout the year. Please note there is a feature in the on-line fire safety system whereby you can delegate access for data entry and/or viewing of the fire inspection data. This element of the process is at your local discretion.

As the new system rolls-out over the course of the next year, we are fully aware that some school districts may be required to have their annual fire inspection performed sooner than they would have anticipated under the old system. This cannot be avoided. Wherever possible, we've done our best to match the old zones with the new regions. **The updated fire inspection schedule is attached to this letter.**

School districts and BOCES whose annual fire inspection data is due to the Office of Facilities Planning on or after July 1, 2015 must enter that data into SED's Application Business Portal after which school districts and BOCES will be responsible for printing their own annual certificates of occupancy. Additionally, the “Big 4” city school districts (Buffalo, Rochester, Syracuse, and Yonkers) will be integrated into the geographic region where they are located. In other words, the fire inspections for the Yonkers Public School District will be scheduled during the same cycle as the rest of Westchester County.
