Use of Indoors Pyrotechnics (Fireworks):

Use of indoor pyrotechnics requires the authority having jurisdiction to issue the appropriate use permit. In New York State, the authority having jurisdiction for public schools is the State Education Department. The State Education Department will not issue permits for indoors pyrotechnic displays in public school buildings. Stage and other productions may continue to use fog machines or dry ice, as long as the use does not interfere with exiting from the building.

The code section that applies for this is Section F3308.1 of the new Fire Code of New York State which states that the display of fireworks for indoor use must comply with National Fire Protection Association (NFPA) Chapter 1126, Standard for the Use of Pyrotechnics before a Proximate Audience. NFPA Chapter 1126 Section 4.1.2 states that the authority having jurisdiction shall approve the use of all pyrotechnics.

Fill for Athletic Fields:

Please check this out. This is a link to a letter written by Carl Thurnau to Superintendents School Districts regarding the use of free "fill" from construction sites placed over their athletic fields in order to receive "free" improvements for the same athletic fields. We are concerned about proper design, drainage/runoff, the possibility of contaminated fill, and compliance with various regulatory agency requirements.

Effective immediately, these projects will require a full review by Facilities Planning Staff. Permits and oversight from other regulatory agencies such as New York State Department of Environmental Conservation may also apply. A full environmental review of these projects may help to mitigate many of these concerns.

Asbestos Designer's Qualifications:

It has been a long standing Policy of the State Education Department to require asbestos designers to have a current Department of Labor Certificate **AND** be a R.A or P.E. licensed in New York State. When asbestos work is involved in a project both of these items must be provided to Facilities Planning with a project submission. When the project design firm does not have this qualified individual within their firm it is common for them to hire a sub-consulting firm to provide the asbestos design service.

The completed documents should have the seal of the R.A or P.E. asbestos designer on the specification cover with the other professional seals or on the first page of the asbestos specification.
