Sullivan West CSD will be using funds in three main areas: Social Emotional Needs, Technology and The focus was on re-engaging students to make up for lost seat time during COVID-19 response. Sullivan West has increased the mental health support team, adopted the RULER IQ program. Trauma based cousneling has been instituted. Dealing with grief, parental job loss, or dislocation was adressed by mental health professionals in the district. The district also expanded the allocation of one to one devises for students in addition to other technology needs.
