**Background and Instructions****Background**

Section 9-a of part A of chapter 56 of the laws of 2021, as amended by §5-a of part A of chapter 56 of the laws of 2022 requires, on or before July 1, 2022, every local educational agency (LEA) receiving funding from the Elementary and Secondary School Emergency Relief (ESSER) funding from the American Rescue Plan (ARP) act of 2021 to post on its website and submit to the New York State Education Department (NYSED) an updated plan of how such funds will be expended and how the LEA will prioritize spending on non-recurring expenses as defined in section 9-a(1) of part A of chapter 56 of the laws of 2021. This updated plan must include:

- An analysis of public comment;
- Goals and ratios for pupil support;
- Detailed summaries of Investments in current year activities; and
- Balance of funds spent in priority areas.

**Instructions**

The *State Budget Reporting Survey* is due by July 1, 2022.

LEAs must complete all sections and are required to answer questions marked with a red asterisk. If a required question has not been completed, the business portal will highlight it in red and the section of the application will be flagged. The applicant will be unable to submit the application to NYSED for final review if a required question remains unresolved.

The online application may only be submitted/certified by the chief school officer of the applicant LEA. The designated superintendent (public school LEAs) or the chief executive officer, board of trustees president, or school employee designated by the board of trustees (charter school LEAs), are the only administrators with the submit/certify rights necessary to successfully submit and certify a completed application for NYSED review.

LEAs are NOT REQUIRED to send hard copies of survey materials to the Department.

Ember Charter School initially provided opportunities for public comment relative to the district's ARP ESSER Plans and use of funds at Board of Trustee meetings held during the months of August 2021, September 2021, October 2021, November 2021, December 2021 and January 2022. These meetings were conducted to discuss Opening Plans and review Plans for the use of ARP ESSER funds. During meetings held in February 2022, March 2022, April 2022 and May 2022, reporting of usage of ARP ESSER Plan was share with Board and with the opportunity for public comments.

Since these initial discussions at public meetings, Ember CS has had on-going discussions of the use of funds at weekly Leadership Team Council meetings engaging the Partnership, the Executive Officer, Dean of Students and Senior Members form the Teaching Staff, Operations and Deans Team. Additionally, discussions were also with parent schoolhouses meetings were stakeholders were given the opportunity to discuss ongoing usage of ARP funds which include the purchase of technical devices, software and platforms for students and staff members as well as to supplement the costs for programming in Afterschool, Spanish studies, & Reading strategies and mental services for students, families and staff members.
