The Office of Higher Education (OHE) newsletter describes the current and upcoming activities related to higher education, with a particular focus on the preparation of educators. This newsletter, past newsletters, and a subscription link are available online on the OHE website.

BOARD OF REGENTS SEPTEMBER ITEMS

New Students with Disabilities (All Grades) Certificate. The Board of Regents adopted a regulatory amendment to establish the Students with Disabilities (All Grades) certificate and revise the extension to teach certain subjects to students with disabilities in grades 5-9 or grades 7-12 for eligible special education teachers. New York State institutions of higher education can apply to register SWD (All Grades) programs beginning September 28, 2022. The registration requirements for this program, including the coursework and clinical experience requirements, are posted on the Office of College and University Evaluation website. The Department will no longer register new programs leading to the current SWD (Grades 1-6) and SWD (Grades 7-12) certificates on or after October 1, 2022. All SWD (Grades 1-6) and SWD (Grades 7-12) programs will be discontinued on or after September 1, 2029. New Literacy (All Grades) Certificate. The Board of Regents <u>adopted a regulatory amendment</u> to establish the Literacy (All Grades) certificate. New York State institutions of higher education can apply to register Literacy (All Grades) programs beginning September 28, 2022. The registration requirements for this program, including the coursework and clinical experience requirements, are posted on the <u>Office of College and University Evaluation website</u>. The Department will no longer register new programs leading to the current Literacy (Birth-Grade 6) and Literacy (Grades 5-12) certificates on or after October 1, 2022. All Literacy (Birth-Grade 6) and Literacy (Grades 5-12) programs will be discontinued on or after September 1, 2026. Net. The Board of Regents <u>adopted a regulatory amendment</u> to create a safety net for the revised Business and Marketing CST that allows candidates to take either the revised CST or the predecessor CST in Business and Marketing for one year after the revised CST becomes operational on September 12, 2022. The test framework and study guide for the revised CST are available on the <u>NYSTCE website</u> for candidates and teacher preparation programs to assist in preparing for the revised test.

ASSESSMENT VOUCHERS

The annual assessment fee vouchers for the <u>NYSTCE tests</u> were sent by email to the Education Deans and Directors on September 26.

Certification for College Professors. The Transitional G certificate is one option for current and former college professors to obtain certification and teach in New York State public schools. College professors can also become eligible for the Initial certificate through the individual evaluation pathway to certification by either: (1) gaining two years of satisfactory teaching experience while holding the Transitional G certificate; or (2) completing at least six credits of undergraduate pedagogical coursework or four credits of graduate coursework in specified areas, such as the methods of teaching. The Department proposed a regulatory

<u>amendment</u> to remove the requirement that college professors' relevant experience be completed within 10 years immediately preceding the Transitional G or Initial certificate application date and allow college professors to meet the education requirement if they have a baccalaureate degree in the area of a certificate title (or in a closely related subject area acceptable to the Department), as long as they possess a graduate degree in another area. NEW OFFICE OF TEACHER AND LEADER DEVELOPMENT AND ASSISTANT COMMISSIONER

The New York State Education Department (NYSED) has created an Office of Teacher and Leader Development to bring together the various units charged with teacher and leader development under one umbrella. This new office will enable the Department to more deeply consider policies and supports for developing stronger and more diverse teacher and leader recruitment and retention opportunities; pre- and in-service professional learning opportunities; and better inform educator certification through a strong connection to the field, research organizations, and a deep understanding of the law and regulations. The office will coordinate efforts across the continuum of P-20 offices, serve as content experts and a resource on school leadership, and ensure that the needs and concerns of teachers and school leaders have an active voice in our shared work.

Alexander Trikalinos has been appointed as the Assistant Commissioner for the Office of Teacher and Leader Development and brings extensive knowledge and experience in teacher and school leader development and professional learning. He holds a Juris Doctor from Albany Law School and started his career as a classroom instructor and master tutor. He started with the Department in 2013 as an Education Specialist in the Office of Teacher and Leader Effectiveness where he provided support and technical assistance to stakeholders regarding statutory and regulatory requirements for developing and implementing teacher and principal evaluation systems. Mr. Trikalinos then held the position of Interim Director of that office and was subsequently promoted to serve as the Executive Director, a position which he has held since 2016.

Content Specialty Test (CST) Frameworks. The frameworks for the new <u>Computer Science CST</u>, revised <u>Physical Education CST</u>, and new <u>School Counselor CST</u> are now available on the <u>NYSTCE website</u>. The frameworks can assist candidates and educator preparation programs in preparing for the assessments.
