The Office of Higher Education (OHE) newsletter describes the current and upcoming activities related to higher education, with a particular focus on the preparation of educators. This newsletter, past newsletters, and a subscription link are available online on the OHE website.

## **BOARD OF REGENTS OCTOBER ITEMS**

DASA Training. Prior to the October Board of Regents meeting, the six-clock hour Dignity for All Students Act (DASA) training for certification could be offered entirely online through December 31, 2021 in response to the COVID-19 pandemic. At its October meeting, the Board of Regents adopted an emergency measure to continue allowing the DASA training to be provided entirely online after December 31, 2021 until the proposed amendment to remove the three-clock hour face-to-face instruction requirement for the training becomes permanently adopted and effective on March 2, 2022. It is anticipated that the proposal will be presented for permanent adoption at the February 2022 Regents meeting.

#### **ACCREDITATION AGREEMENTS**

The New York State Education Department has signed state partnership agreements with the <u>Association for Advancing Quality in Educator Preparation</u> (AAQEP) and the <u>Council for the Accreditation of Educator Preparation</u> (CAEP). The agreements are posted on the <u>Office of College and University Evaluation website</u>.

**Definition of University.** At its February 2021 meeting, the Board of Regents considered <u>an updated definition</u> of "university" that was sent out for public comment. In response to concerns expressed by commenters and the significant changes in the delivery of higher education across the nation and globally, the Department <u>proposed a revised regulatory amendment</u> at the October Board of Regents meeting to further update the definition of "university" in New York State to read:

"University means a higher educational institution offering a range of registered undergraduate and graduate curricula in the liberal arts and sciences, including graduate programs registered in at least three of the following discipline areas: agriculture, biological sciences, business, education, engineering, fine arts, health professions, humanities, physical sciences and social sciences."

This proposed definition provides an opportunity for those institutions that offer a range of academic programs at the undergraduate and graduate level to petition the Board of Regents to amend their charters to use the word "university" in their names. It also ensures breadth and depth of academic offerings by requiring institutions that identify as universities to offer a range of registered undergraduate and graduate programs in the liberal arts and sciences, including graduate programs in at least three of the 10 NYS Taxonomy of Academic Programs discipline areas identified above. It will allow those New York chartered institutions that qualify and secure subsequent charter amendments to more effectively compete and market their programs within the state, nationally, and globally.

## PHYSICAL EDUCATION LEARNING STANDARDS PRESENTATION

The New York State Education Department (NYSED) is hosting the "Statewide NYS Physical Education Learning Standards Introduction and Rollout" presentation on November 10, 2021 from 10:00 a.m.-11:00 a.m. The presenters are Darryl Daily, Associate in Instructional Services, Physical Education in the Office of Curriculum and Instruction, and Dr. Clancy Seymour, Associate Professor and Director of Health, Physical Education & Sport Pedagogy at Canisius College. This virtual meeting is open to practicing physical education teachers and physical education teacher preparation program faculty. It will provide updates on the rollout of the <a href="NYS Physical Education Learning Standards">NYS Physical Education Learning Standards</a>, the status and tentative implementation timeline, and professional development resources that are being developed. It will be conducted via Zoom and limited to the first 1,000 participants. ## SPECIAL EDUCATION STATE PERFORMANCE PLAN STAKEHOLDER ENGAGEMENT ACTIVITIES

The New York State Education Department (NYSED) is seeking to engage stakeholders in activities to improve outcomes for students with disabilities in New York State. The input of diverse groups of parents is extremely important to this process. Please distribute the <a href="SPP Stakeholder Invitation Letter">SPP Stakeholder Invitation Letter</a> in your communities to encourage participation and ensure feedback from a variety of voices and viewpoints. The State Performance Plan/Annual Performance Report (SPP/APR) includes 17 indicators that measure child and family outcomes as well as compliance with the requirements and purposes of the Individuals with Disabilities Education Act. NYSED is currently developing the SPP/APR for the new six-year cycle. As part of this process, stakeholder engagement is critical to assist in setting targets and developing improvement activities to strengthen and support outcomes for students with disabilities. Stakeholder engagement activities will include broad public engagement and input through online surveys and virtual meetings with stakeholder groups in November 2021.
