The Office of Higher Education (OHE) newsletter describes the current and upcoming activities related to higher education, with a particular focus on the preparation of educators. This newsletter, past newsletters, and a subscription link are available online on the OHE website.

BOARD OF REGENTS DECEMBER ITEMS

Coordinator of Work-Based Learning Programs Extension. The Department proposed a regulatory amendment to create a new, single "Coordinator of Work-Based Learning Programs" extension that would replace the following two current extensions: "Coordinator of Work-Based Learning Programs for Career Awareness" extension and "Coordinator of Work-Based Learning Programs for Career Development" extension. The proposed extension would enable educators to coordinate a wider range of work-based learning programs. The certification requirements for the proposed extension will be the same as the base certificate, coursework, and experience requirements for the current "Coordinator of Work-Based Learning Programs for Career Awareness" extension, with some minor revisions. The registration requirements for programs leading to a coordinator of work-based learning programs extension would continue to be at least six semester hours of coursework in developing, implementing, coordinating, and evaluating work-based learning experiences and programs. The proposal will not require institutions that have registered programs leading to this type of extension to revise their programs. ALTERNATIVE MODELS OF FIELD EXPERIENCES

The Department is extending the alternative models of field experiences flexibility to teacher preparation programs during the 2022-2023 academic year with certain modifications, as described in a memo to Deans and Directors. Specifically, field experiences can be completed through alternative models, if the program is not able to secure or provide placements for candidates due to extenuating circumstances beyond the program's control. The flexibility does not apply to student teaching or practica. The Dean or Director of Teacher Education Programs must notify the Office of College and University Evaluation (OCUE) about the use of alternative models by completing the "Notification of Alternative Models of Field Experiences" form where they will describe the extenuating circumstances. The OCUE website includes the memo, form, and a definition of alternative models of field experiences.

NEW YORK STATE GRADUATION MEASURES DISCUSSION

The Blue Ribbon Commission on Graduation Measures would like to know: What skills and abilities are most needed by NY State graduates to succeed in their chosen post-secondary path? Individuals can participate in the discussion about this question via ThoughtExchange. The deadline to respond is January 9, 2023.

NEW ARTS LEARNING STANDARDS RESOURCES RELEASED

The Office of Standards and Instruction has released two new Arts Learning Standards resources:

- An <u>Arts Assessment Think document</u> which provides arts educators with a series of questions and resources for developing and considering formative assessment strategies and experiences with their students.
- An arts teacher <u>Need to Know document</u> on the <u>Culturally Responsive-Sustaining Education</u>
 <u>Framework</u>. This document presents the four principles of the framework with questions for consideration by arts educators.
