Survey Information (Section 130.7 (b) (1-8) • New York State compulsory education law places, with some exceptions, the primary

- New York State compulsory education law places, with some exceptions, the primary
 responsibility for confirming that students attending nonpublic schools are receiving substantial
 equivalent instruction upon the Local School Authorities (LSAs). Substantial equivalency is based
 upon the provision of instruction in the core subjects required by state law (science, math, social
 studies, and English language arts). The regulation creates pathways through which religious and
 independent schools can demonstrate that their instruction meets the requirements.
- The Board of Regents promulgated Part 130 of the Commissioner's Regulations regarding this statutory requirement.
- Completing the Substantial Equivalency Survey Form described in this document will help LSAs comply with Section 130.7(a) of the Commissioner's Regulations by providing the ORISS with a list of all nonpublic schools located within the LSA's geographical boundaries.
- LSA's reporting of all the nonpublic schools that serve compulsory age children (from age 6 to 16 in most jurisdictions, age 17 in others) within their geographical boundaries and the date of the last substantial equivalency determination made for each nonpublic school is due September 1, 2023 and each September 1 thereafter. The survey will reopen prior to December 1, 2023 for SE pathway reporting and enabling LSAs to report any additional information they were not able to by September 1.
- Pursuant to Section 130.7(b) of the Commissioner's Regulations, the SE reporting of <u>pathways</u> is due December 1, 2023.
- Note: LSA's are only required to report the date of the last substantial equivalency determination by September 1, 2023 if the date is known.

- Section 1: LSA reviews the pre-populated list of religious and independent schools within your geographical boundaries and enter applicable SE information.
- Section 2: LSA manually enters information for schools that are not listed/pre-populated in section 1.

Username Assistance

Password Assistance

- 1. Go to the **portal** website.
- 2. On the top of the right-hand side, click on Reset Password.
- 3. Enter your username and email address then click in the check box next to where it says, "I'm not a robot."
- 4. Click the Submit button.
- 5. You may be prompted to answer random questions for the reCAPTCHA system.
- 6. You will then get a confirmation page and an email will be sent to you to finish changing your password.
- 7. In your email, click the link that says reset Password.
- 8. A new site will open, and you will choose your new password there. Enter it twice. The page will inform you if it is not correct or if you have used it before.
- 9. Go back **portal** and enter your username and new password.
