**Office of Religious and Independent School Support (ORISS)**  
**Mathematics, Science & Technology (MST) Teacher Reimbursement Grant**

**Purpose:** The Mathematics, Science & Technology Teachers (MST) Grant provides New York State (NYS) religious and independent schools with reimbursement for teacher salary expenditures related to Mathematics, Science, and Technology.

**Governance:** The MST program is governed by Section 3037 of Education Law and administered by the New York State Education Department (NYSED).

**Eligibility:** Institutional Eligibility

1. Religious and independent schools (non-profit or not-for-profit schools only)
2. Currently open/operational (at the time of application)
3. 853 and 4201 schools are not eligible
4. Possession of (or will obtain) a valid Office of the State Comptroller (OSC) Vendor ID
5. New York State Education Department (NYSED) issued Basic Education Data System (BEDS) code
6. BEDS enrollment data for 2024-2025 school year for grades 3-12

Teacher Eligibility

1. An eligible teacher is categorized as one of the following:
  - a. Certified to teach in New York State pursuant to Section 3004 of Education Law;  
or
  - b. Holds a master's degree or Ph.D. in one or more of the following subject areas:
    - i. Mathematics
    - ii. Science
    - iii. Technology
    - iv. Education; or
  - c. Holds a bachelor's degree in mathematics, science, technology, or education and is currently enrolled in a master's or Ph.D. program in mathematics, science,

technology, or education within five (5) years from the date of April 10, 2020, or the employment start date with the religious or independent school.

2. Teaches mathematics, science, or technology in any grade from three (3) through twelve (12) using curricula that support the New York State learning standards.
3. Does not provide non-secular (religious) instruction in any capacity.
4. Is employed by a religious or independent school during the 2024-25 school year.

Applicants are **strongly encouraged** to complete their MST Year 8 submission through the [NYSED Business Portal](#). This web-based system improves submission quality, reduces the need for follow-up, and increases the efficiency of claim processing and reimbursement. To access the [NYSED Business Portal](#), schools must have a **User ID, Password, and access permissions**.

Below are some additional resources to help you navigate the rest of the MST grant process.

**Deadline:** In accordance with Education Law § 3037(2)(a) ORISS must receive the complete submission and accompanying documents by **August 1, 2025**.

**For the purpose of the MST grant, the following definitions will apply:**

### **Non-Secular Instruction**

Pursuant to Education Law Section 3037, teachers providing instruction in mathematics, science, or technology and providing non-secular (religious) instruction in any capacity for all or part of the school day are not eligible.

### **Teacher**

An employee of a religious or independent school whose responsibility is to create and instruct students using a research-based curriculum guided by the New York State learning standards in mathematics, science, or technology.

Please note that non-primary, instructional support, and non-classroom educators are not eligible teachers for the MST grant and include:

- Consultant Teachers
- Teacher Aides or Teacher Assistants
- Librarians or Library media specialists
- Speech Language Pathologists
- Physical or Occupational Therapist/Therapist Aids
- Tutors
- Substitute Teachers

**Technology Education: Definition**

Commissioner’s Regulations Part 100.4 (a)(1) defines technology education as defined as a program of instruction designed to assist all students in meeting state intermediate standards for technology. Technology education uses concepts of science, mathematics, social science, and language arts in a hands-on, systems-based approach to problem solving that guides students in the understanding, design, and development of systems, devices, and products to serve human needs and wants.

**Reimbursement Methodology:**

In accordance with Education Law § 3037(2)(b), reimbursement for eligible teachers shall be the average comparable teacher salary and personal service, per subject area, of public-school teachers in the school district in which such nonpublic schools are located, multiplied by the percentage of full time equivalent secular instructional hours completed in the school day per subject area. Reimbursements shall not be provided for eligible teachers who provide instruction in mathematics, science, or technology, if such teachers also provide non-secular instruction in any capacity.

Per Education Law § 3037(2)(c), in the event that the total reimbursements requested exceed the appropriation available for this program, then each applicant shall only be reimbursed an amount equal to the percentage each such applicant represents to the total of all applications submitted.

Applicants should keep in mind; eligible teacher salaries have historically exceeded their reimbursement rate (last column of the chart above). Employing religious and independent school must support the remaining expenses and should not plan to receive additional reimbursement.

**Dataset:** NYSED’s Information and Reporting Services (IRS) collects and reports annual data on public school districts and schools. For Y8 of the MST grant, the 2024-2025 School Year data will be used for the calculations.
