High-Tech Security Features

Albion Central School has applied for funds for a High Tech Security upgrade. The district wishes to replace the existing analog emergency notification system. This antiquated public address system that they depend on during an emergency event is over 15 years old. While that wouldn't normally be a crisis, the company has discontinued this product and no longer provides replacement parts. The estimates for installation of the 487 classroom and public area devices approved in the original application were much to low to complete the work. The district has filed this amendment to increase the available funds for installation.
