 Describe how you intend to use Smart Schools Bond Act funds to install high-tech security features in school buildings and on school campuses.

The Argyle Central School District is proposing to upgrade and replace internal and external I.P. digital security cameras throughout the district. The security cameras currently installed are analog cameras in which the picture is blurry and specific details are difficult to identify. The cameras and current software are considered "end of life" with several cameras unusable and unreliable in their current state. The digital cameras will allow for an enhanced picture quality. The district will be able to cover current blind spaces and public areas that are uncovered.

The second component of the plan are actually the door latches for the classroom doors. Traditionally, classrooms doors were locked with a key. When the teacher arrived in the morning, they unlocked the door. The door was open or at minimum, unlocked for the rest of the school day. In the event of an emergency, the teacher needed to step into the hall and lock the door. Argyle is proposing to replace these doors with wireless locks. When the teacher or administrator approaches, they will "swipe" their card and the door will unlock. After they enter they can decide if they want the door unlocked or locked. In the event that a swipe card turns up missing, the card can be disabled and it will no longer allow unauthorized people to unlock the door. IN the event of an emergency, the administration can lock all of the doors from the main office or from their Smart phone immedicately so the teacher isn't forced to compromise the slearning environment.

All labor estimated in this proposal is per Municipal regulations and prevailing rates for this region in New York state.
