The Smart School Planning Committee for the Baldwinsville Central School District has always made school safety and security their number one priority. During the last eight years they have invested Smart School funds in Video Security, Door Security, and window film to reduce the vulnerability to intrusion from the extensive number of glass windows in the district. Three years ago, the district submitted an application to expand their video security system. In the interim, the district administration approached the Committee asking them to consider adding addition Concealed Weapons detection systems to the High Tech Security list. That item has quickly moved from a single building priority reflected in the application from 2023 to a district wide priority.

The Baldwinsville District has decided to move the Video Security project to funding from the Safe Schools Act and to a Capitol project.

They wish to purchase additional Concealed Weapons detection equipment with the funds that would then be available. This application reflects that priority and request.
