High-Tech Security Features

1. Describe how you intend to use Smart Schools Bond Act funds to install high-tech security features in school buildings and on school campuses.

Due to changes in technology, additional and enhanced security features are now available with newer classroom locks. The cost of hardware and software has increased due to updated pricing, additional required licensing, more advanced classroom locks, and some additional doors that were added to the project.

All classroom doors and sensitive areas will have a wireless or wired locks with Prox-card reading capability. This will give the district the ability to lockdown the entire building, by specific zone(s), or as granular as a specific door. The previous locks only had a single use lockdown capability and still required physical keys.

Physical keys will no longer be necessary for most faculty and staff. Prox-Cards can be disabled electronically reducing unwanted access versus physical keys which may be lost or stolen. Locks will not have to be re-keyed in this scenario.
