The District's intent in the Initial Smart School's Submission was to purchase approx. 690 Chromebooks and to continue to provide 1:1 computer accessibility in grades 2-2 and K-1. In amendment #1, we requested funds to transfer for high tech security to purchase additional security cameras. These costs came in lower than anticipated and we were also able to utilize different funding. We would therefore like to reallocate these funds back to Classroom Learning Technology and purchase laptop computers. We have purchased approx. 619 chromebooks under SSIP#1 and with this amendment we would look to purchase an additional 45 under SSIP #1.

Our existing platforms and systems will support the purchase of these items and the district has the adequate electrical /HVAC and other infrastructure needed to support the operation of these purchases.
