## High-Tech Security Features

1. Describe how you intend to use Smart Schools Bond Act funds to install high-tech security features in school buildings and on school campuses.

The Buffalo City School District's current recording platform was installed in 2007 and has reached manufacturers end-of-life for support since 2014. Since then, there have been a number of industry improvements both for camera quality imagery and higher performance network capacity for storage of video surveillance content. This SSIP submission will procure new 360 degree cameras and higher capacity recorders. The implementation of new 360 degree camera technology will allow for greater overall coverage compared to existing fixed cameras at a lower camera count. In addition, updates will be made to enhance data rack power infrastructure in order to maintain and protect electronic equipment in the event of emergencies and outages. Plus, power upgrades will allow the district to fully leverage technology enhancements such as the District's security system, as well as its wired and wireless network infrastructure.
