High-Tech Security Features

1. Describe how you intend to use Smart Schools Bond Act funds to install high-tech security features in school buildings and on school campuses.

The Buffalo City School District's current security recording platform was installed in 2007 and has reached manufacturers end-of-life for support in 2014. Since then, there have been a number of industry improvements both for camera quality imagery, better forensic capabilities, and higher performance network capacity for storage of video surveillance content. This SSIP submission will procure new 360 degree cameras, higher capacity recorders, security workstations with high definition capabilities for work staff, and the associated software platform necessary for the core functionality of this equipment. The implementation of new 360 degree camera technology will allow for greater overall coverage at a lower camera count. As a result of implementing this new system, the District will gain greater functionality while achieving a lower overall maintenance cost and less power consumption.

PA systems are also being replaced that have reached end of life. These new PA systems will be integrated with our VoIP phones system and intrusion for added security capabilities. Instant notification, preprogrammed emergency announcements, remote access to the system, and the ability to do both school and district-wide emergency announcements are new security features within this new PA system. Further, in the event of a lockdown in which power and data connectivity are unavailable, each site is locally available to broadcast emergency information.

The new PA system is capable of automatically send an email to as part of a programed series of events to notifying administrators of an emergency. Provides the ability to view the emergency status of all buildings. Provides the ability to check the status of individual classrooms in the event of an emergency.
