We are currently running a Hyper-V server environment and Cisco Meraki wireless to deliver internet to our entire school population. Our Hyper-V host run on a Dell VRTX system. We currently provide a 500 mbps connection through fiber. Our current Hyper-V environment is reaching end of life and must be replaced in order to continue to provide reliable, DNS, DHCP, security, and access to all services for all students, faculty and staff.

These servers provide the access to Internet, all software, printing, storage, and district authentication. Replacement of the Hyper-V host is key to continuing to provide this service to our school district. The current host has

The district is looking to upgrade its classroom workstations to further enhance teaching and learning in the district. The workstations will be compatible with all of the Ed Law 2-d compliant software that the district purchases and provides to its students and staff. These workstations will serve as instructional tools to provide access to AI, Internet resources, presentations, and interactive tools as well as be utilized by staff and students to communicate with all stakeholders. Additionally the district would like to begin replacement of classroom interactive displays to improve classroom instructional practices.
