Because of the time elapsed from the original proposal to the approval of the plan, we were able to defray some of the original costs through purchasing some equipment with other funds, including several cameras. We also determined that the 224TB server was unnecessary, and that the load could be managed by a second 160 TB server, which was a significant cost reduction.

However, there is an overall increase in cost due to the overall increase in price of many of the items, as well as the installation fee and engineering/programming/project management services.

We are adjusting prices by backing out the original planned costs for most items and replacing with the actual costs in order to free up dollars allocated per item, per the direction of the Smart Schools team.
