High-Tech Security Features

 Describe how you intend to use Smart Schools Bond Act funds to install high-tech security features in school buildings and on school campuses.

The Central Islip Union Free School District's video surveillance system currently includes 295 cameras, the majority of which are analog, to provide limited coverage of our nearly 1mm sq. ft. of building space and 200+ acres of grounds at 8 campuses. This SSIP proposes to replace all old analog cameras with digital cameras, add 300 cameras to provide full interior and exterior coverage of our buildings and grounds, replace outdated servers with new NVRs and unify our camera system with our to-be-expanded door access and control system. The current door access system operates independently of our security camera platform, monitors/controls only 3-6 exterior doors per location, and does not maintain real-time lock down capabilities. Expansion and upgrading of the access system will enable exterior door access exclusively via electronic fobs (synchronized to our real-time active directory) thereby enhancing security and affording administration with the ability to effectuate "single button lock-down" of exterior doors. The access control system will provide door ajar alarms enabling security staff to identity when an unscheduled door opening occurs. The unified system will integrate with our PA and VOIP phone system to improve administration's ability to communicate in emergency situations and initiate lock-downs from various locations. The unified system also provide for integration with local-jurisdiction police and replaces our 30+ year old burglar alarm/intruder systems with more modernized systems less susceptible to false alarm triggers. The SSIP also includes the creation of a central command center from which district security, administration and first responders can monitor and direct control of the unified platform control system.
