Many of our students have limited piror learning experiences, the visual clarity and ability to be manipulated, our teachers and students can support connections to in school learning with the world. All of our teachers are teachers of students with disabilities and English Language Learners; we support the instructional approach to modify content, build prior knowledge, and visual cues. The interactive boards will provide a critical tool our educators need to support this approach. Our

We have a Technology Integrator who provides a variety of professional learning opportunities for our instructional staff throughout the school year. Our Technology Integrator is key to attending state-wide and regional instructional technology conferences and turn-keying information to our entire staff. This individual uses varies professional learning models such as classroom coaching, before and after school sessions. This individual was key in investigating various interactive white boards on the market, working with teachers and vendors to support a match in need, and sharing out with the Technology Committee and district leadership.

Historically, this individual has provided professional learning on some of the topics below:

- LG and Newline Interactive White Boards: Classroom Push-in, Before and After School Sessions
- Chromebooks: Classroom Push-in, Before and After School Sessions
- PowerSchool: Classroom Push-in, Before and After School Sessions
- Online Instruction Programs (Lexia, Castle Learning, eDoctrina, Benchmark Advance, Kami, IXL, etc.) Classroom Push-in, Before and After School Sessions
