 Describe how you intend to use Smart Schools Bond Act funds to install high-tech security features in school buildings and on school campuses.

The previous amendment removed the secure vestibule and then applied to use those security funds for additional cameras and the new classroom communications system in the high school. Those items were never purchased. Other issues in the district took priority and those items were postponed.

During the interim, the public address systems in both buildings have failed unexpectedly. Because of their antiquated technology, spare parts are not available and repairs have been temporary at best. This proposed amendment will replace the existing emergency communication system with an ip based system this will eliminate "dead areas" where the existing analog system has failed. The new IP based system will also allow the district to preload announcements for emergency situation to insure accurate and timely information is provided to staff and students. The addition of IP based system provides both audio and visual alerts for both school buildings. Finally, the new ip based system can be monitored by the IT staff and failures can be identified before they are an issue instead of waiting for an emergency and then realizing some students didn't get the message.
