Our first goal in our technology plan is to sustain a robust, secure network to ensure sufficient reliable high speed connectivity for learners, educators, and leaders. Our current installed switches are no longer robust and will not support future infrastructure needs. The district has accomplished several of the action steps including moving to a cloud-based wireless controller, and updating the fiber between the buildings. The technology department will be updating the wiring in the closets as part of this project but only the switches and accompanying accessories are part of this Smart Schools Bond Act.

The technology departments our bandwidth during different peak times. We know we have a robust Wi-Fi network. The technology department also monitors the device load on access points. We have added additional access points to high traffic areas to support access. The project we are starting to replace switches with newer, more robust, and with more monitoring capabilities will support both our Wi-Fi network and our ability to monitor our network.
