In August 2023, the district completed a comprehensive wireless network upgrade, replacing all legacy equipment with two Aruba 9240 wireless controllers and Aruba AP 635 access points across all facilities. This enhancement delivers high-speed Wi-Fi 6E connectivity, providing reliable, high-capacity coverage to support both instructional and administrative operations. With this modern infrastructure, the district currently meets—and is well positioned to exceed—the state's connectivity speed standards for years to come.

The district continuously assesses wireless network demand by analyzing the total number of active devices, including student Chromebooks, staff laptops, tablets, and other instructional technologies. Network utilization data from the Aruba Central management platform is actively monitored to track bandwidth consumption and client density across all access points.

The 2023 upgrade to Aruba 9240 controllers and Aruba AP 635 Wi-Fi 6E access points was strategically designed to support high-density environments and anticipate future growth in device usage. Each access point delivers multi-gigabit throughput and dynamic bandwidth allocation, ensuring consistent, high-performance connectivity even during peak usage periods such as state testing or building-wide instructional activities. The district will continue to analyze usage trends and make capacity adjustments or deploy additional access points as needed to sustain optimal network performance and meet evolving user needs.

The district plans to purchase a total of 1,065 Chromebooks—325 for grades 3–5, 320 for grades 6–8, and 420 for grades 9–12—along with 50 laptops for middle and high school teachers. The district has tested and verified that these devices will operate efficiently within both the current and planned upgrades to the network and wireless infrastructure. Each classroom will be equipped with charging stations to ensure students can easily recharge their devices. No impact to HVAC or electrical systems is anticipated.

The proposed technology investments will enhance differentiated instruction, expand student learning opportunities both inside and outside the classroom, and help address identified learning gaps across the district.

The vision of Eden Central School District is to foster a collaborative learning community that values each student's individuality, empowering them to become productive citizens in an ever-changing and diverse world. The district's approved Technology Plan outlines four goals to support this vision. Goal One is currently being addressed through district funding and ongoing professional development, while Goals Two, Three, and Four will be strengthened through this SSIB submission, particularly in the area of professional development as described in Question 8.

Teachers and students will leverage modern technology to enhance traditional instructional practices and advance the district's shift toward inquiry- and project-based learning. These learning environments require current tools that allow students to personalize their learning and demonstrate understanding through multiple forms of media.

The proposed devices will also expand collaboration among students at the classroom, school, district, state, national, and global levels. Integrated with the district's learning management system and the Google Workspace for Education suite—including Gmail and related applications—students and teachers can seamlessly share assignments and assessments electronically.

Google Workspace is a widely adopted, web-based platform accessible from any internet-connected device. It supports differentiated instruction by allowing students to engage with materials at their own pace and ability level.

1:1 student devices, Chromebooks and iPads (not included in this SSBA submission) also serve as critical assistive technology for students with disabilities and English Language Learners. Applications such as Google Translate, Proloquo, and TalkIt provide equitable access to curriculum, instructional materials, and assessments. Collaboration between the technology and special education departments ensures that students' Individualized Education Program (IEP) requirements are met effectively.

By providing these devices, the district increases opportunities for practice, remediation, and reinforcement of instruction. Because the tools are internet-based, they naturally support the integration of subjects and real-world learning experiences, preparing students for success in a digitally connected and rapidly evolving world.

The district maintains an active website, a mass communication system for phone, email, and text messaging, and an anonymous web-based bullying reporting platform. In addition, all teachers have direct access to student and parent email communication through the district's student information system. Parental engagement in students' academic activities enhances communication and collaboration between home and school.

The proposed device purchases will further strengthen the district's technology environment, supporting more effective communication among parents, students, staff, and the broader school community. Through the district's learning management system, the "Parent Portal," families can monitor their child's academic progress in each content area.

The collaborative tools within Google Workspace for Education expand students' ability to work with peers across their class, school, district, state, nation, and even internationally. These platforms enable virtual collaboration beyond the limits of the traditional classroom, allowing students to engage in group projects and discussions anytime, anywhere. Built-in device cameras also support face-to-face video collaboration, connecting students with others around the world and enhancing global learning opportunities.

Technology Plan Goal Two: Integrated Learning System

The district has standardized on Google Workspace for Education (formerly GAFE) and Google Classroom after piloting several systems and offering introductory workshops. Teachers have opportunities to participate in workshops provided by BOCES Model Schools, WNYRIC, or other professional development providers. In addition, teachers may request individualized training with one of the district's Technology Integrators. Establishing and integrating an online curriculum through Google Workspace and Google Classroom is an ongoing process, supported by continued staff development opportunities such as Model Schools workshops, Teacher Center workshops, regional workshops, or other professional learning experiences at colleges or conferences.

Technology Plan Goal Three: Implementation of ISTE Technology Standards by Teachers

All teachers are required to self-evaluate their teaching relative to district technology goals. The evaluation reviews progress toward meeting ISTE standards and includes plans for incorporating technology and professional development into the upcoming year. The Director of Curriculum & Staff Development reviews these requests and incorporates them into superintendent professional development days, after-school sessions, or summer workshops. If needed, teachers may also participate in Teacher Center workshops, regional WNYRIC workshops, or other professional development opportunities to meet specific technology curriculum requirements.

Technology Plan Goal Four: Personalized Learning Plan

Developing and implementing a personalized, inquiry-based learning plan is a top district priority. The district participates in a BOCES pilot with Education Elements™ to support staff development and the implementation of a personalized learning plan for administrators and teachers. While personalized learning can occur without technology, the district's 1:1 device initiative enhances its effectiveness. Pilot teachers in early grades receive a full class set of devices, along with a printer, charging cart, and a yearlong Model Schools training program that includes both pull-out and push-in sessions. Additional classroom teachers receive a smaller set of devices with grade-level specific Model Schools training. As new devices are implemented in lower grades, existing shared technology resources are reallocated to upper-grade classrooms, accompanied by continued Model Schools professional development.

The district encourages all teachers and administrators to pursue professional development aligned with their curriculum needs. Options may include weekend courses, research projects, mini-grants, Teacher Center workshops, WNYRIC regional workshops, or other professional development opportunities at colleges or conferences.
