The increased WiFi Capability will be esential tawards enhance the Chromebooks efficacy and speed.

#### Teacher Laptops:

Our teachers will require an updated Laptop to assist them in their teaching and professional development. Our technology committees recongnized the need for a device that would be portable and could be used if remote learning was required as was realized during the Covid 19 Pandemic. Remote flexibility is a must for our needs. The Laptops will use multi use input docks in the classroom to directly access our network and connect to multiple monitors or other systems such as Document Cameras. Also these devices will be able to connect to our Wlfl network so teachers can be portable within the school district.

The Chromebooks that we ill be purchaseing will have touch screens for tactile learning, Microphones for Dictation and speech recognition which will benefit foreign language acquisition and fluency, and Cameras for video creation and phonics awareness. With every student being provided with a device we will be able to give students these learning tools as well as provide accessibility options that can help enhance learning and support special area needs. The Teacher Laptaps will give teachers flexibility to move around their classroom and work with students while also using their device for teaching, learning, and communication. The teacher latops will have full Windows 11 Operating System and have a webcam and a built in microphone. This will allow teacher sto create lessons in a variety of formats to meet students needs.

Our teachers communicate regularly with teachers face to face but also using remote means during parent conferences etc. Since the Teacher Laptops will come with Microphones and Camera Capabilities, these devices can be used for remote teacher conferences which often make parent/ guardian communication easier. These can also be helpful for Board of Education meetings which sometimes require remote guests or presentations.

Additionally, we do offer a variety of Distance Learning Activities through Erie2 Boces Distance Learning Consortium. This educational entity helps schools connect remotely to educational platforms across the country and world, expanding ours students and families perspectives about other cultures and landmarks.
