Geneseo Central School has always prided themselves on the safety of their schools and students. The students thrive in the positive learning environment and being able to focus on learning. The new millennium has demonstrated the challenges that schools across America face to continue to provide this safe environment for their students. Geneseo Central School would like to upgrade and expand portions of their security programs to continue to provide this positive learning environment.

The first priority of this application is to improve the access control on doors that are used by the public to enter the buildings. Schools see a regular passage of members of the community into the buildings. Geneseo wants to facilitate the speedy entrance of individuals with a proper reason to be there. Th district is proposing that the primary entrances to the Main Building be equipped with Video Door bells. When an individual approaches the locked doors, they will ring the bell. They will then be asked to identify themselves and the reason they are entering the building. "I am Susie Smith's mom and I am here to sign her out for an orthodontist appointment." Or perhaps "I am John Jones from the Alumni Association and I am here to meet with the principal regarding the Alumni Reunion next month." With proper identification, the door lock will be released and the visitor can enter the building. While the alternative is unusual, this will help the community have confidence in the ability of the building staff to monitor authorized visitors to the building. In addition, The Main Building at Geneseo was designed to offer multiple exits in case of a fire or other emergency. While the convenience is great, the vulnerability of these doors limits the security of the building. Geneseo Central School is proposing to install door monitoring contacts on all exterior doors. When the door is opened, an indicator will sound in the main office. If the door is blocked open, the building leadership can be dispatched to remedy the situation.

Finally, Geneseo Central Schools previously completed an upgrade to the Video Security system. Upon completion, they identified three vulnerable locations on the exterior of the Main Building. Those cameras are included in this application. NO Facial Recognition capacity is included in this application.

All labor rates are NYSOGS prevailing wage rate as required by NY State Law. The architect fees are negotiated with the architect and are commensurate with other negotiated rates at neighboring districts.
