The District planning to install View Sonic Interactive panels into every classroom throughout the building. The District will be purchasing 55, 75 inch panels and 8, 65 inch panels. The original plan was to have 30 panels be mounted on portable carts, 33 will be mounted directly to the walls in the classrooms. This has adjusted to only 13 be mounted to carts and the rest be wall mounted. In additional with the savings from going to wall mounted to cart mounted we were able to make available fund to cover the wifi adapters, wall mounting kit, and some of the Installation cost for the interactive whiteboards.
