Upgrading the wireless access points at locations within the secondary schools are of critical importance. These access points were installed in 2015, which was the infancy of the district's 1-to-1 device initiative. Since that time, Wi-Fi usage and total connected devices have increased drastically by 7 times. The access points that are currently installed can no longer support the current workload of users, which results in limited to no connectivity. Furthermore, the WAP model currently in use will reach end of support in June 2024. As a result, we are planning to utilize a portion of the Smart Schools Bond Act funds to upgrade access points in order to improve performance, bandwidth and increase Wi-Fi density throughout necessary locations.

To ensure a strong Wi-Fi network connection to accommodate the high demand from staff and students using wireless devices, we have conducted a needs assessment to determine the number of users, types of devices and applications that will be used. As a result, we have a clear understanding of the bandwidth requirements and the areas where coverage is critical. Network coverage has been mapped out and network has been designed to ensure comprehensive coverage and sufficient capacity. With the use of the Smart Bond funds, we will be investing in upgraded access points to strategically cover all areas effectively. We will continue to maintain high capacity routers and switches as well as a robust backend infrastructure to manage the increased data flow.
