High-Tech Security Features

1. **Describe how you intend to use Smart Schools Bond Act funds to install high-tech security features in school buildings and on school campuses.**

To enhance the safety and security of our students, staff, and visitors, the district intends to use funds to purchase and install Alta Aware cameras throughout school buildings and across campus grounds. These advanced security cameras offer real-time video analytics and activity monitoring, allowing our security personnel to proactively identify and respond to potential threats. This software does not have facial recognition because it is not allowed.

The implementation of Alta Aware cameras will strengthen perimeter and internal surveillance, improve emergency response coordination, and provide valuable investigative support after incidents. Cameras will be strategically placed to maximize visibility in high-traffic areas, entry points, and exterior zones such as parking lots and playgrounds. Video data will be securely stored and managed in compliance with NYSED data privacy standards.

This investment aligns with our broader commitment to creating a safe, welcoming learning environment and supports our district's long-term safety planning, including integration with existing building access control systems and threat assessment protocols. This will allow us to retire an old outdated system and move over to one system instead of having two programs for video, old and new.
