 Describe how you intend to use Smart Schools Bond Act funds to install high-tech security features in school buildings and on school campuses.

All schools value the safety and security of their students. Hamburg Central Schools has identified this as a priority for their Smart School funding. The district wishes to upgrade and expand their video security system. The current system has been in use for a number of years. Unfortunately it is an analog system with very limited capacity.

Hamburg Cental is proposing to install a video security system that expands the capacity and coverage in the district.

The first component of this system is the server capacity for storage of the video. The current system has very limited storage capacity. Events are missed, or the records age out before they can be examined in detail. The new system will have adequate storage capacity to save in excess of 30 days of video. Additionally, the system has the capacity to archive a specific video of a specific event indefinetly. The record of an event or incident can be saved indefinetly for any future reference.

The second component is the actual coverage by cameras. The current system covers some of the primary entrances to buildings as well as some of the main traffic congestion areas. The new system will expand the coverage inside the buildings in the halls and the main assembly areas as well as alternate entrances and exits. The system will also cover areas of the campus including parking lots and playgrounds. In the event of a incident, multiple views of the event or perpetrators will be available.

All plans and specifications for the erection, repair, enlargement or remodeling of school buildings in any public school district in the State must be reviewed and approved by the Commissioner. Smart Schools plans with any expenditures in the High-Tech Security category require a project number from the Office of Facilities Planning. Districts must submit an SSBA LOI and receive project numbers prior to submitting the SSIP. As indicated on the LOI, some projects may be eligible for a streamlined review and will not require a building permit.
