1. **Describe how you intend to use Smart Schools Bond Act funds to install high-tech security features in school buildings and on school campuses.**

The district has previously invested in security systems including IP surveillance cameras, card swipe access systems and door alarms. Further, the district has also invested in mantrap entrances with monitored visitor management systems. The district will use Smart Schools funds to replace older network infrastructure that supports these systems.

Primarily, the internal infrastructure of our security network will be upgraded. This includes servers, network attached storage and the equipment to develop a storage area network (SAN). These systems were originally installed in 2017 and, due to the manufacturer's support ending, will need to be updated. Cameras have been added and updated under a previous SSIP and this second phase serves to support our robust security systems. This is a one for one replacement of servers and SAN's that are reaching the end of their serviceable life.

Visitor kiosks are an important component in securing daily access to our buildings. Visitor management allows the district security team to verify visitors identity and what their purpose of business is on any given day. Visitor management systems will check government issued ID's against certain databases and allow security personnel to track who is in the building. Further, these systems will provide temporary visitor badges to be worn while in the building. Previously, the district has invested in the hardware for these systems and continually renews licensing and software agreements. As with all technology hardware, life cycles do exist. This expenditure will be used for one to one replacement the CPU hardware of our visitor management system. All required licensing costs are again included in the proposed 2024-2025 school budget.
