Originally, the first phase of the Smart Schools plan included the purchase of iPads to support student learning. However, after further evaluation of instructional needs, device usage trends, and technology integration across grade levels, we determined that Chromebooks would better serve our students and staff. Chromebooks offer greater compatibility with our existing learning management systems, assessment platforms, and online instructional tools. They also provide more robust functionality for typing, research, and project-based learning, aligning better with our curriculum goals. As a result, we are reallocating the planned funding to purchase Chromebooks instead of iPads to ensure we are meeting the evolving educational needs of our students. The allocation for the iPads in the original plan has been reduced and those funds will be applied to the purchase of the additional Chromebooks. Additionally, the cost variances have all been accounted for in this amendment and the net result is incorporated into the amendment.
