Jamesville Dewitt proposes to upgrade their infrastructure using Smart School funds. The upgrades include upgrading Cat 6A on the "last link" including the WiFi connections. The district also proposes upgrading their fiber backbone to support 10 gig connection speed. These connections will provide a long term support to students who increase the network requirements every year.

Finally, the key locations on the network are the Main network distribution closet and the Intermediate distribution closets. These locations were selected and assembled on a piecemeal basis with little consideration to security and redundancy. Jamesville Dewitt proposes constructing dedicated spaces that include secure doors, redundant power, and air conditioning. These improvements will increase the reliability and extend the life of the equipment.

Jamesville - Dewitt Central Schools believes that all students are more successful if they are active participants in learning rather than passive receivers of knowledge. Jamesville Dewitt Central School has implemented and wishes to continue to support independent student learning via a one-to-one learning environment. The network infrastructure to support this learning environment was constructed over the last 20 years in a fragmented process as funds were available.

Jamesville-Dewitt is proposing to upgrade this network to provide the support that students require.

Jamesville Dewitt Central Schools wants to construct a network to support student learning. The district assembled a team that included instructional administrators, network administrators, and consultants from the district architect team for technical planning and design.

This team, on an on-going basis reviews the instruction assignments in each space, the number of potential students, and the network support for learning in those spaces. As demands change, the team recommends adjustments to the network infrastructure that might be required in those spaces by changes in the instructional program.
