The new security cameras are state of the art and will have wide lenses which will enable those who monitor the cameras to have a clearer picture and wider view, both inside the building and out, providing a safer, more secure educational environment. The District will also purchase a door badge reader that will allow access for authorized personnel at a point of entry that is used frequently throughout the day.

All plans and specifications for the erection, repair, enlargement or remodeling of school buildings in any public school district in the State must be reviewed and approved by the Commissioner. Smart Schools plans with any expenditures in the High-Tech Security category require a project number from the Office of Facilities Planning.
