The district intends to purchase a 3D printer and 6 eReaders which are compatible with all software and programs currently in use at the district. No additional infrastructure is needed to support this additional technology. The District also intends to purchase a domain controller for the server which is also compatible with all software and programs currently in use and does not require additional infrastructure to support it.

Grades 4-6 will be participating in a program called TinkerCat and will learn programming to design three dimensional objects which they will then print with the 3D printer. This program connects directly to the technology curriculum and plan.

The district has a DL lab which can be used to facilitate course offerings that we can not offer on our own. The proposed new technology will help ensure that students who are in DL classes have the best connectivity and experience possible as well as enhance communications with parents and the community.
