We intend to use the funds to purchase Chromebooks. This will maintain a 1:1 ratio for students and devices. This also allows for the potential use of virtual learning and distant learning. We found during the Pandemic that students' ability to have readily available devices allowed for a seamless transition to online learning. The available devices also allow families who may not have available technology at home to connect with the school. For some families, we provide hotspots through a different funding source. Those hotspots, along with devices, enhance the ongoing communication with parents and stakeholders. There is also an opportunity for language translation, which will help with our new ENL families.
