The original devices included in LakeGeorgeCSD23 were the PowerLite WXGA 3LCD Ultra Short-throw Laser Projectors (4000 lumens). These projectors have been discontinued, therefore they are removed in this amendment. Added to this amendment are the replacement projectors, the PowerLite 760W Wireless WXGA 3LCD Ultra Short-throw Laser Projectors (4100 lumens). The replacement projectors are \$282.19 more expensive than the original projectors, therefore, there are only 23 of them added in this amendment. Additionally, 12 mounting brackets were removed in the amendment to stay below the remaining allocated amount for Lake George Schools.
