Every learning space has a projector and Apple TV. With the district's 1 to 1 device program, both teachers and students can project wirelessly in every learning space. This allows teachers to share content and students to share their thinking from anywhere in the space, allowing for flexible engagement. These proposed projectors are replacements for existing equipment. Therefore, the necessary power and infrastructure are already in place. They are compatible with the existing wiring and peripheral devices (Apple TVs, Elmos, etc.)/

The weLearn 1:1 program ensures that students K-12 have access to a device. Students in grades 5-12 can take their devices home on a regular basis. Students in grades K-4 utilize their devices at home in times of need (remote learning, medical absences, etc.). Students and families are surveyed annually to gather information about internet access at home. Mobile hot spots are provided to students, families, and staff in need of access from home. IT support is accessible to students, families, and staff through a digital help desk ticket system, email, or phone access.

Students with disabilities have access to both an iPad and a Macbook, when appropriate. Additionally, students with disabilities may utilize specialized keyboards and headphones. Instruction and assessment are differentiated with the use of software and apps. Some current examples include, but are not limited to:

- Software programs and apps that allow for modification of tasks Read & Write, Overdrive Audio Books, note taking apps (i.e. notability), rewordify
- Software programs for organizing content and tasks Read & Write outlining features, Kami, Google Classroom, Graphic Organizer tools
- Progress Monitoring and skill development Fast Forward Reading Support, TeachTown Applied Behavior Analysis, Learning A-Z, IXL Math, Reflex Math, Intervention Central, Readworks, NewsEla
