To meet this demand, the District has added access points to each classroom. The access points are controlled by a centralized controller that allows us to manage the wireless devices from a single console.

The addition of the proposed technology will continue to allow us to provide a continuity of instruction to all learners including our English Language Learners & students with disabilities. Various supports for students with disabilities can be accessed utilizing technology. This includes access to online remediation programs in ELA, Math, and Social Studies. Additionally, students with disabilities who may have executive functioning difficulties will benefit from the organizational support that these technology devices offer. Students in class will have opportunities to be engaged, see exemplars, and have sequential steps demonstrated on the interactive flat panels. These same instructional supports will assist our English Language Learners with the additional benefit of automatic translation being readily available in both the interactive flat panel display and the Chromebooks.

Each student would be able to access the differentiated lessons and instruction based on their abilities and needs while still participating in the general curriculum aligned to their grade levels. By providing devices to all students, the district can ensure equitable access to instruction, materials and assessments to all students helping to bridge learning gaps.

The proposed technology purchases will enhance ongoing communication with parents and stakeholders by ensuring equitable to access for all families regardless of economic status. Distance learning is supported for full remote and hybrid learners via the chromebooks and the interactive flat panels which will allow live streaming instruction to take place.
