The charging stations that we purchased in the first amendment ended up costing less than originally intended. Furthermore, due to a shift in the way we distribute devices, we required less of them. In this amendment, we'd like to take the savings from this and apply it toward the purchase of additional, updated items that were approved in the original plan; specifically we are looking to purchase additional iPads. With the last remaining funds we would also like to purchase two computer monitors to be utilized in our classrooms.
