The Smart Schools Bond Act funds will be used to upgrade and modernize the security and surveillance systems at both the high school and middle school, addressing the limitations of our current, outdated system. The new system will significantly improve the safety and security of our school campuses by incorporating state-of-the-art technology designed to provide comprehensive coverage and high-quality footage for monitoring purposes.

The upgraded system will include a total of 134 indoor cameras, 86 outdoor cameras, and 21 multi-directional cameras in the high school, along with 79 indoor cameras, 62 outdoor cameras, and 23 multi-directional cameras in the middle school. All cameras are equipped with high-resolution lenses, wide-angle views, anti-glare and shadow-resistant features, and are vandal-resistant. Additionally, these cameras utilize artificial intelligence to enhance monitoring capabilities, allowing for smarter detection of unusual activity and improved overall security response.

To support the enhanced surveillance system, the schools will also be equipped with Power Over Ethernet (PoE) switches, battery backup systems, servers, cabling, and display terminals. Both schools will have upgraded Security Operations Centers, which will allow for real-time monitoring and better response coordination.

By covering more areas of the campuses with high-quality, reliable surveillance, this system will act as a significant deterrent to potential security threats and enable quicker, more accurate responses to any incidents. The system will improve the safety of students, staff, and visitors while also providing valuable footage in the event of investigations.
