The Livonia Central School District is linked to their Internet Service Provider via TIme Warner Cable. This provides the district with up to 1 gigabyte of bandwidth.

As a component to the security component of this project ALL switches will be upgraded to POE capacity with 10 Gigabyte backbone connections. The most important component of this project and Erate Category 2 has been the upgrading of the wireless network to saturation coverage in all instructional spaces in the district. Livonia's long range goal is to establish a one-to-one environment. The continued upgrade of the network is critical to a successful project.

The primary goal of the Livonia Central School Technology Plan is the establishment of a one-to-one instructional environment. In the preliminary application the district upgraded and expanded all of the wireless infrastructure to accomplish that goal. In this application the district wishes to strengthen the back bone infrastructure with this supplementary application. This will continue to strengthen the capacity of the district as they increase the demand on the network.

In the preliminary stage the design team visited every instructional space and quantified the immediate and future demands for instruction and security in each area. The Preliminary application addressed the wireless capacity. This supplementary application expands on that upgrade to provided a limited "future proof" to the network.
