The District added a high tech, secure vestibule area at the main entrance to Homer Brink Elementary Schools. There are over 750 k-5 students in this building, and there are a lot of parents and visitors on a daily basis and the district wanted to insure student and staff safety. This allows the staff in the vestibule to view visitors entering, request identification through a intercome system. Once entered, the district uses the T Pass system to scan their drivers license and make a visitors badge.
