#### High-Tech Security Features

The current system to enter and exit buildings needs to be expanded in line with the previous submission. The District must keep all exterior doors locked at all times but allow employees of the District to gain easy access by utilizing an identification card reader. Currently there is no way to physically activate a lockdown at the buildings.

Many older video cameras do not provide enough clarity and/or coverage in the District. In addition, older software does not allow viewing of multiple cameras at the same time.
