Due to the almost two year time period it took for approval, some of these items were purchased through a Capital Project and some of the prices changed in that time period as items were quoted and purchased. The purchases were made while waiting on approval as the walls were opened and items needed to be added and approval had not been obtained at the time. We are now looking to free up the funds for an additional Smart Bond Project. During this time period there were also price adjustments to the original prices of the items submitted and were paid for out of the Capital Project and General fund, while some were partially or fully purchased using smart bond funding so that the project could continue. Because of completing during a capital project, there are funds in this plan that we wish to unallocate, to be used in a future plan.
