#### Original Plan

We planned to purchase 2,412 Chromebooks (or equivalent portable device) and 42 interactive whiteboards/displays. Chromebooks and interactive displays are part of a six year district-wide instructional technology replacement plan.

#### **Revised Plan**

Of the 2,412 Chromebooks planned for purchase as part of our original (2021) plan, 220 were purchased in 2021, 478 were purchased in 2023, 183 were purchased in 2024, and 360 were purchased in 2025. We would like to reduce the number of chromebooks designated for purchase in our 2021 plan from 2,412 to 1,241. To reconcile planned quantities and costs to actual purchases and costs we have removed all planned chromebook quantities and costs and added all actual chromebook purchases and costs to this amendment.

Of the 42 interactive boards planeed for purchase as part of our original (2021) plan, 20 were purchased in 2022, 20 were purchased in 2023 and 2 were purchased in 2025. To reconcile planned quantities and costs to actual purchases and costs we have removed all planned viewboard quantities and costs and added in all actual viewboard purchases and costs to this amendment. The goal of this amendment is to reconcile the <u>planned</u> expenses to the <u>actual</u> expenses, resulting in releasing unused dollars from the original plan, to be used in a future Smart Schools Plan.
