High Tech Security has received the priority for the majority of the Smart School Bond work at McGraw Central School. In previous applications the district replaced the existing emergency notification system with an IP based system that generates the audio at the end device. This system reduces the reliance on a single amplifier and allows the district IT staff to identify problem areas in advance. Also, this system allows the district to "pre-load" certain emergency messages that could be broadcast via commands from an administrators remote device. In the event that an administrator identifies an emergency, they are not forced to sprint back to the main office to start emergency procedures.

During the installation of the previous plans, the district has identified public areas and Large Group Instruction areas that require additional resources. The equipment designated for a 700 square foot classroom is not sufficient for a cafeteria, or a Large Group presentation space. This application requests that the remaining funds for the district be released for this priority. This application includes digital speakers as extensions of the digital display devices that have been installed. Those additional speakers guarantee that the back corners of the large spaces receive a loud message in addition to the front. There are also mounts for the devices, additional digital display devices.
