The school districts first technology plan goal is to "support a secure teaching and learning environment for grades PK-12 through technology enhancements." The District wants to ensure their students feel and are safe to learn. With the focus of supporting a safe learning environment, the Smart Schools Bond Act funds will be used to update the classroom announcement system with ip speaker/displays. Currently, the classrooms have only speakers and clocks. Many of the speaker/clocks are over 30 years old and some are broken. The proposed system will allow for emergency notification in the classrooms, allowing for both audio and visual communication. It will become part of the integrated control system should there be an emergency, and allow for quick notification of all stakeholders, clear instructions and the ability to quickly access and respond to an emergency situation.
